
Waiting for a Bus that Won't Come





Lack of Support from the University

As well as the risk for tickets and towed cars all because vans and vehicles are parked in areas that are designated for students.

Provide Service and Lessen Inconvenience

There are multiple screenshots submitted to an anonymous Instagram account for students to complain about issues occurring at the University of New Haven. The first two pictures on the left-hand side of the collage refer to the courtesy vans (a student support transportation service) using university time for selfleisure. One can only wonder where the vans when actually needed. The remaining two pictures on the right-hand side refer to other issues commuter's face by University staff and police whether it be taking parking designated for University students (top right photo) or being blocked in by them. Increased competency of university personnel to ensure they helping transport students to where they need to be on time and increasing parking for people on campus to avoid simple issues as demonstrated above.



Insufficient Parking in Designated Lots



The view outside of an Atwood apartment window showing the minimal available parking spots to residents here. The lot here is shown to be full to the point where students need to park on the street. This risks their cars' safety if left overnight, the time when rising car thefts are taking place.

Not in Compliance

In this photo, a parking (un)compliance vehicle is shown to be parking in a "blue permit only" spot. Again, showing how university vehicles take parking spots from not only students who need them, but staff as well.

No Entry

This is the commuter parking lot located next to Celentano Hall. University police has frequently closed the Celentano gate during the middle of the day (even with multiple parking spots still available). I had to circle back around campus again because this lot was closed (for alleged safety purposes although the gate does not surround the entire property for trespassers coming in a car). I gave up and drove down to the Railroad Salvage Parking lot and had to walk back up the hill with an injured knee because surprise! The UNH shuttles did not come.
